**ITEM #1      CALL TO ORDER**

#### **A. DIRECTOR'S REPORT**

##### **1. PERFORMANCE REPORTS**

The Board reviewed the WIA, Work First and Employment Service reports.

##### **2. REPORT ON APRIL 27, 2005 MICHIGAN WORKS! LEGISLATIVE DAY**

It was reported that 23 out of 25 MWA's in the state attended the Michigan Works! Legislative Day on April 27. Chairman Tim Quinn, Saginaw County Commissioner/Consortium Board member Carl Ruth and Ed Oberski attended the event.

The legislative goals of the Michigan Works! Association are: 1) to restore Work First funding to 2001 levels; and 2) to fund Work First entirely out of TANF. Attendees from our MWA met with State Representatives Roger Kahn, Carl Williams, John Moolenaar and State Senator Mike Goschka.

##### **3. UPDATE ON GOVERNOR'S INITIATIVE TO PLACE 30,000 JOBSEEKERSW INTO EMPLOYMENT**

It was reported that the Governor had sent letters to between 250,000-280,000 employers requesting that they pledge job openings in the state. "Michigan Opportunity Partnership" program training will be conducted this week for relevant contractor staff.

It was reported that the several MWA and contractor staff visited the Michigan Works! Agency in Escanaba, Michigan. Their system of registering job seekers, dealing with businesses, etc. was reviewed. Staff from that Michigan Works! Agency have been invited to our MWA to present their business service methods.

##### **4. UPDATE ON STRATEGIC PLAN GOAL TO EMPHASIZE BUSINESS SERVICES**

It was reported that a Business Services Unit has been established to work with and contact employers. Arnold Center, Bangor Township Schools, SVRC Industries, Inc. and Delta Corporate Services will provide staff for the core group.

##### **5. APRIL 18, 2005 CORRESPONDENCE FROM DLEG ENCOURAGING CO-LOCATION WITH DHS**

The Board reviewed the April 18, 2005 Correspondence from DLEG with encourages co-location with DHS.

## 6. COUNTY OF SAGINAW AUDIT

Ray Ogden, Finance Manager, presented the County of Saginaw audit for the year ending September 30, 1994 had no audit findings. The audit includes all funding and programs administered by Saginaw Midland Bay Michigan Works, and it made no findings applicable to those programs or funds.

### **ITEM #10 NEW BUSINESS**

#### **A. DIRECTOR'S RECOMMENDATION FOR CHANGES TO THE STRATEGIC PLANNING PROCESS**

The Board reviewed the director's recommendation for changes to the strategic planning process. It was suggested that a committee be appointed which would meet, review and report back to the WDB on specific areas that need to be addressed.

Tim Quinn stated that he and Ed Oberski will discuss possible approaches and report back to the WDB.

#### **B. STAFF RECOMMENDATION TO INCREASE SAGINAW COUNTY FRIEND OF COURT CONTRACT**

The Board reviewed the staff recommendation to increase the Saginaw County Friend of the Court contract amount by \$45,000. This amount would provide funding for one attorney and one support staff from June 1, 2005-September 30, 2005.
