A. State Apprenticeship Expansion Grant Presentation

This is an \$11 million grant which is intended to expand the registered apprenticeship program across the state. Great Lakes Bay Michigan Works! is looking to partner with Michigan Works! Region 7B to develop a RAP to expand registered apprentice opportunities across an 11 county region. The intent of this initiative is to create an apprenticeship program encompassing multiple industries and career pathways that provides credentials that will be universally recognized by employers statewide. Great Lakes Bay Michigan Works! Administration will provide a high-level overview of the grant framework with the intent of gathering feedback and ultimately support from the CEAC for this initiative. Administration plans to ask for the highest amount of the grant, which is \$1.1 million.

B. Virtual MiCareerQuest Middle Michigan

The MiCareerQuest Middle Michigan Executive Committee has identified a virtual platform to serve as a temporary replacement for the in-person event: vFairs. Although this model cannot replace the impact of the hands-on experience of MiCareerQuest Middle Michigan, it will allow for the crucial one-on-one, career exploration experience in a COVID friendly setting. This platform will allow employers to get their logo out there. It can host up to 8,000 people at one time. Each student will have a swag bag, and the system will email their interests from the event to their personal email. Part of the event registration will allow students to chat with employers and get information before the initial event actually begins. After the

event, vFairs will run reports for post-event analysis. The date for this event will take place on October 29, 2021.
