a) MiCareerQuest Middle Michigan 2022 Recap

Interim CEO Wenzel reported to the CEAC that MiCareerQuest Middle Michigan 2022 was a great success. There are floor plan changes that will be implemented for the 2023 event, but the flow of 2022 event was better than 2019, and there were no issues with the bus scheduling like there was in 2019. C. Discussion:

a) Strategic Plan Update – Lee Ann Rouse, Omni Tech

Lee Ann Rouse presented the Michigan Works! Strategic Planning Update. Items that were presented were the Lean Strategic Planning Process, the Strategic Plan Roadmap, Environmental Scan & Stakeholder Data Collected, a High-Level Summary of Common Themes and Opportunities, a Draft of New Framework, the Vision Map, a Draft of the 2023-2025 Strategic Plan, and the 2023 Plan of Work.

b) Registered Apprenticeship Program (RAP)

Interim CEO Wenzel introduced Jerry Russell to the CEAC as the Apprenticeship Success Coordinator for Great Lakes Bay Michigan Works!. Jerry is working in the private sector and the labor sector and is attending meetings regionally for anything pertaining to apprenticeships. Geno stated she sits on Apprenticeship Advisory Expansion board, as well as the Youth Apprenticeship Subcommittee. The Youth Apprenticeship Subcommittee has worked hard to develop a user-friendly Youth Manual that consists of the most relevant and important information. The hope is that this manual will be finalized soon.

c) Michigan Apprenticeship Readiness Certificate (MARC)

Geno stated that this certificate has been created to align with pre-apprenticeship programs. There are specific guidelines for funding through Michigan department of ed, so we have been ensuring that the alignment is set up correctly to make sure there is a seamless transition for certificate holders, starting with youth as young as 16 years old. The goal of MARC is to help mentor youth and educate them that they don't have to leave the region to obtain a good job. These pre-apprenticeship certificates have a couple of levels: 1) foundational skills with a basic credential and 2) is more customized to a particular industry, with employer input.

d) Future Agenda topics

Ongoing discussion around registered apprenticeship, sharing what everyone is doing (Geno). To piggyback off that, Klele and his IBEW team have investigated solar apprenticeships and have yet to come up with anything. Klele will try to get his hands on the standards for solar apprenticeships and will come back with whatever he can find.
